1. Information on eligibility, mechanisms on how to enter, prizes and the information in the Schedule form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. **Eligibility:** Entry is open to Australian residents aged eighteen (18) years or over (**Entrants**). Employees, immediate family members, retailers, suppliers, associated companies and agencies related to the Promoter are not eligible to enter in the promotion. All entries of Entrants who are under the age of eighteen (18) years and who enter the promotion will be deemed invalid.
